THE CONSTITUTION OF: ULTIMATE OUTLAWS RACEWAY:

All motorsport events are held under the Rules and Regulations of Motorsport SA/Speedspot

SECTION A

1. The name of all promotions and/or shall be The Ultimate Outlaws Raceway, it's applicable to all divisions/categories.
2. The objective of the promoter is to promote motorsport in all its branches, to encourage social activities between the persons engaged in the sport and include development and training.
3. *Ultimate Outlaws Raceways promoter and its members will refrain from manifesting racial, political, disablement, gender, or religious discrimination in the cause of its activities.*
4. Ultimate Outlaws Raceway shall be known as a **promoter's club**.
 - 4.1 The promoter may from time to time appoint or request nominations to appoint a working committee/class representator to assist with the smooth running of the club and its members, this committee/class representator shall be known as class captains for team leaders and shall serve on a committee.
 - 4.2 Competitors and officials shall refer all matters, issues, and disputes to their appointed team leader, who in turn will find an amicable solution or revert such undissolved matter to the committee.
 - 4.3 Team leader duties – carry their own code of duties and agreements.
5. The headquarters of the promotions will be situated at the auditors appointed by the promoter.
6. The membership period shall be from 1st February – 31st of January valid for 12 months each year.
 - 6.1 Club Championships will be counted from the first event held in January/February up until and including December.
 - 6.2 Club Championship award functions will be held after year close of date and in agreement with it's members:
 - 6.3 To accommodate Club Champions per class: Only classes with more than 6 registered active club members will be accommodated as club Champions.
7. All proceeds received from a race meeting, or any other form of income derived by the promoter, or its members could be used for: additional donations, after expenses regarding venues, drivers, track rental and repairs, insurance, maintenance or any other expenses that may occur, have been deducted.
8. The promoter will not be obliged to advertise or display financial income and expense statements of the promotion company.
9. Driver meetings for each category shall be conducted every six months, unless otherwise agreed and specified, whereby a set of minutes will be taken and forward to any member asking for the minutes.
10. Any request, enquiries or complaints during meetings will be conducted in a proper manner through the chair, and in no other way. Any member has the free right to contact the Chairman to communicate any dislikes in a proper way or manner.
11. Club members of Ultimate Outlaws Raceway/MSA/Speedspot or Womza have no right to put down, threatened or intimidate any promoter/ chairman/ competitors/ official of any club whatsoever. In case this happens action will be taken against such individual putting the sport and our club in disrepute. If found guilty of such an offence the member may be banned for a minimum of 6 months or a minimum fine of R5000. Each case will have its own merits.

12. Club members at Ultimate Outlaws Raceway wishing to participate at other clubs shall obtain approval from Ultimate Outlaws first. Failing the club would be entitled to penalize the club member with at least a ban of three months or a R5000 fine. Each case will have its own merits.
13. In All meetings the Chairman will have a casting vote in addition to his ordinary vote.

SECTION B

MEMBERSHIP OF ULTIMATE OUTLAWS RACEWAY

1. New membership applicants are to complete a standard application form, which requires some information about the applicant.
2. Membership shall be open to any person, subject to such application being accepted by the promoter/committee/chairman as being a person worthy of membership, **and in sympathy with the objects of the sport.**
3. Any paid member has the right to approach the promoter, chairman and include the committee with a valid complaint against any new proposed member. The applicant will be informed if they were declined, 2 weeks after the receipt of the application.
4. In extreme cases the promoter and chairman in concert may grant permission for temporary membership until such time as the application has been approved.
5. The promoter/chairman reserves the right to accept or reject any membership if a member is misbehaving or misusing benefits of club membership or bringing disrepute to the sport.
6. **Non-Active member's** membership renewals will be based on its own merit. After 6 months of non-active memberships, members may lose all club membership benefits. Promoter/Chairman will deal with these issues based on each on its own merit.

Membership General:

7. In terms of the country constitution members may hold membership at more than one club, body, organization if they are compliant with the motorsport body regulations and is an active members in these different classes.
 - 7.1 Ultimate Outlaws do not support or accommodate any Groups or Associations.
 - 7.2 All competitors participating at Ultimate Outlaws Raceway must be a registered club member at Ultimate Outlaws Raceway or a registered club member at a club that is affiliated to the controlling body.
 - 7.3 No competitor will be allowed to compete without a valid Licensed issued by the controlling body.
8. Club Member Fees and race entry fees will be determined annually.
 - 8.1 Race entry fees may differ from category to category and as per different championships.
 - 8.2 Annual Membership Fees are payable by the end of March each year or as per agreement with promoter.
 - 8.3 Voting of newly appointed committee members and team leaders, shall be processed at the first meeting of every year or when there is a resignation of a Committee member or Team Leader.
 - 8.4 Failure to renewing membership by the 31 March each year, the membership of such a member will be cancelled.
9. Members found guilty of bad behavior, breach of the sporting regulations, all other forms of misconduct irrespective of the nature shall be classified as bringing the club/promotor/chairman or the sport into disrepute. The Promoter will have the right to hold a hearing against the offender and will appoint hearing members.
 - 9.1 Physical encounters on the property shall result in an automatic ban of 3 months.
 - 9.2 Disrespect towards fellow members and/or officials or security personal on the property of Ultimate Outlaws Raceway/Vaalshow shall call for a hearing and offenders will be dealt with accordingly.
 - 9.3 If the membership is suspended, he/she will be deemed to have resigned from the date of suspension.
10. Resignations and complaints are to be **made in writing** to the promoter or the relevant person in charge of the category.

- 11 Special general meetings may be called for by any member in good standing in writing to the promoter giving the reason for calling such a meeting and signed by 50% of the paid members who are also in good standing. Notice of such a meeting is to be given to all members at least 24 hours before the date of such a special general meeting by the promoter or promoter's appointment.
- 12 The promoter/landlord and/or his/her will not be held responsible for any loss or injury sustained by members of this promoter/landlord, appointed officials and/or his/her during race meetings or practice days or anything otherwise.
- 13 The promoter/landlord and/or his/her does not guarantee any payment for services rendered by any member.
- 14 Any member of the club passing his/her, official, pits or any form of social tickets supplied to them for racing purposes to unauthorized people, will be held liable. A free ticket received by a member may only be used for his/her pit crew, wife, or children. Misusing of free tickets will result in a suspension.
- 15 Any member with any form of insignia connected with the promoter/chairman/landlord/club in an unruly manner anywhere in the republic will be liable for suspension.

16 VOTING RIGHTS OF MEMBERS

Voting rights shall be as follows:

- 16.1 Only paid members of the current year shall have the right to vote.
- 16.2 Race and technical related issues / votes: Licensed Competitors only.
- 16.3 Social members will have the right to vote on promoter/landlord and/or his/her matters.
- 16.4 Officials, who are active and are paid-up members shall be entitled to have a vote on race related issues only.
- 16.5 Voting will be done by ballot.
- 16.6 Proxy votes will be accepted, by SMS, email or WhatsApp sent directly to the promoter.
- 16.7 All votes taking place shall be done by either a show of hands or closed ballot.

The constitution may be changed from time to time. Any such changes will be announced and put forward to the members.

17. CLUB CHAMPIONSHIP EVENTS

- 17.1 Club championship points will be calculated from January to December inclusive.
- 17.2 Visiting competitors shall have the right to earn the prize on the day, and club points **will not be** rescored.
- 17.3 Only fully paid license members shall be entitled to be added to the championship points.
- 17.4 Draws at the end of the championship will be broken by:
 - 17.4.1 the Last event's highest point scorer
 - 17.4.2 if a tie still exists after the last race highest finishing position the final race will break the tie.
- 17.5 If a member is stripped on the last race of the year and found illegal such a member will lose all his points accumulated in the club championships for the year and will be banned for at least 3 months starting the first race in the new season.

18. Penalties and Fines

- 18.1 The club will be obligated to hold a hearing at any time and necessary action be taken, should club members breach the rules and regulations as per club constitution. (Clause B.9 refer)
- 18.2 The club shall be entitled to call for an inquiry into an event if it has become evident that the promoter or official or competitor has breached regulations.
- 18.3 In respect of fines, the competitor shall not be entitled to enter into further events until the fine have been paid. Fines are payable within **7 days** of receiving the fine.
- 18.4 Failure to adhere to the payment time limit will result in the amount be double until it is paid.
